- The deposit is NON-REFUNDABLE if the Buyer changes their mind, cancels, or fails to complete the purchase for any reason.
- If the cattery is unable to provide a suitable kitten (e.g., litter does not produce matching preferences, or health issue preventing placement), the deposit may be transferred to a future litter or refunded at the cattery's sole discretion.
- Once the deposit is received and this form is accepted, the reserved kitten (or next available matching kitten) will be held exclusively for the Buyer and removed from public availability.
- Balance of purchase price is due prior to or at the time of pickup / delivery as specified in the final Sales Contract.
